5) Report on Activities

Main activities since 20th December 2015

a) The Milan Conference

Some surveys of Milan

- 2655 created an account
- 1768 papers presented (1350 accepted)
- 1450 authors
- 1287 badges (908 Grenoble)
- 773 N /313 PhD (28%)
- 170 PANELS SELECTED (on 207)
- 256 SESSIONS
- 1400 papers

The number of participants is higher of 30% compare to Grenoble

b) The partners

8) Some Actions for Next year

The President and the General Secretary presents some actions for next year

- Conclusions of Working groups Method: The working group must produce some conclusion and propose to the EC some concrete actions
- Communication for Association: Actually, there are only communication of the conference. The Main idea is to create a logo and communication tools around the Association. All ICPP become an activities now of IPPA
- Restructuring the Website and the newsletters: All the ICPP Website will be transform in IPPA website with a restructuration of the website
- Organizing a summer school: We work actually on a project on summer school on Public Policy. One of the proposal will be in Firenze in summer 2016
- Organize a first regional conference. If the International conference is every 2 years, we present a new initiative call "Regional Conference on Public Policy" with the idea

to support a conference on public policy in specific area. The project for 2016 is the first Regional Conference will take place at Hong Kong in June 2016

- Try to find new funds. Actually the Association have no permanent staff and this is the real goal for 2016. For this, the association needs to find new funds.
